FEATURES

- Suitable as a sole source of nutrition^ˆ
- 0.83kcal/ml: for patients requiring lower energy diets.¹⁻³
- 55g protein (27%E) per 1000ml: to meet the protein requirements of patients with low energy requirements.

Indications

Ingredients
